Navigation Buoy Warranty

Terms & Conditions

- A. This Limited Warranty applies solely to the JFC Manufacturing Co. Ltd Navigation Buoys manufactured by JFC Manufacturing Co. Ltd and sold to the original purchaser (the "Purchaser"). The Navigation Buoys are collectively referred to as the "Products."
- B. This warranty must be activated by completing the registration form supplied with the product. The completed form must be returned to JFC Manufacturing Co. Ltd by post or email within one month of delivery.
- C. The structural integrity of the Products, when installed strictly in accordance with JFC Manufacturing Co. Ltd's written installation instructions at the time of installation, are warranted to the Purchaser against defective materials and workmanship for three (3) years from the date of purchase. Should a defect appear in the Limited Warranty period, the Purchaser shall provide JFC with written notice of the alleged defect at JFC Manufacturing Co. Ltd's head office within ten (10) days of the discovery of the defect? The notice shall describe the alleged defect in reasonable detail and with photographic evidence. JFC Manufacturing Co. Ltd agrees to repair or replace, at JFC Manufacturing Co. Ltd's discretion those Products determined by JFC to be defective and covered by this Limited Warranty. The supply of replacement products is the sole remedy of the Purchaser for breaches of this Limited Warranty. JFC Manufacturing Co. Ltd's liability specifically excludes the cost of removal and/or installation of the Products.
- D. This limited warranty is exclusive. There are no other warranties with respect to the products, including no implied warranties of merchant-ability or of fitness for a particular purpose.
- E. The product must be packed and returned to JFC Manufacturing Co. Ltd. by the customer at his or her own expense. The returned product must be accompanied with a written description of the fault and a photocopy of the original purchase receipt. On receipt JFC Manufacturing Co. Ltd will evaluate the claim and advise the customer on the course of action.
- F. No representative of JFC Manufacturing Co. Ltd has the authority to change this Limited Warranty in any manner or to extend this Limited Warranty. This Limited Warranty does not apply to any person other than to the Purchaser.
- G. Under no circumstances shall JFC Manufacturing Co. Ltd be liable to the Purchaser or to any third party for product liability claims; claims arising from the design, shipment, or installation of the Products, or the cost of other goods or services related to the purchase and installation of the Products. For this Limited Warranty to apply, the Products must be installed in accordance with all site conditions required by state and local codes; all other applicable laws; and JFC Manufacturing Co. Ltd's written installation instructions and technical specifications.
- H. The limited warranty does not extend to incidental, consequential, special or indirect damages. JFC Manufacturing Co. Ltd shall not be liable for penalties or liquidated damages, including loss of production and profits; labour and materials; overhead costs; or other loss or expense incurred by the purchaser or any third party. Specifically excluded from limited warranty coverage or damage to the products arising from ordinary wear and tear; alteration, accident, misuse, abuse or neglect; the products being subjected to extreme weather conditions. This limited warranty represents JFC's sole liability to the purchaser for claims related to the Products, whether the claim is based upon contract, tort, or other legal theory.
- I. JFC Manufacturing Co. Ltd shall be under no liability under such warranty (or any other warranty, condition or guarantee) if the total price for the Products, has not been fully paid by the due date for payment.
